ROCHESTER ORATORIO SOCIETY, INC. REHEARSAL/EVENT PARTICIPATION COVID-19 AGREEMENT

Please read the following Agreement carefully.

By confirming your registration, you are agreeing to abide by the terms of this Agreement, which includes a waiver and release of liability.

<u>COVID-19 Acknowledgement</u>. I am aware and understand that the World Health Organization has declared a worldwide pandemic based on the COVID-19 virus. I acknowledge that information regarding the virus and how it is transmitted continues to evolve, and protocols and guidelines to reduce the spread of the virus are developing and changing on an ongoing basis. I further understand that the COVID-19 virus may be spread by people in close contact, including by infected people who have no symptoms, and that the risk of transmission may be heightened when people are speaking or singing.

I acknowledge and agree that I am voluntarily registering to attend and participate in rehearsing, performing and recording vocal music. I acknowledge that the COVID-19 virus could be transmitted among participants in and others who may be present at these Events (= ROCHESTER ORATORIO SOCIETY, INC. sponsored rehearsals and performances) despite taking reasonable precautions, including but not exclusively by a person who has no symptoms. I understand that ROS intends to develop and implement rules, protocols and processes, based upon the guidance and directives in effect at the time of the Event from the applicable local, state and national governmental and public health authorities (together, "Guidelines"), intended to mitigate the risk of the transmission of COVID-19 at the Events; however, ROS cannot guarantee that the risk of transmission of COVID-19 at the Events can be completely eliminated. I also acknowledge that the location of the Events, the Asbury First United Presbyterian Church and other performance locations, is under the management and control of that church and other performance locations and not the ROS. I intend to attend and participate in the Events with knowledge of the risks and dangers related to the potential transmission of the COVID-19 virus to me and to other members of my household, and I am voluntarily accepting and assuming these risks, both known and unknown, whether caused by the fault or negligence of ROS, its officers, employees, agents, other participants, sponsors, or volunteers (collectively "ROCHESTER ORATORIO SOCIETY, INC.") or third parties or otherwise.

Acknowledgement of My Obligation to Comply with Guidelines. A critical component of the efforts to protect participants in these Events is the acceptance of a shared commitment by all of those in attendance at the Events to adhere to and comply with the Guidelines, and to act prudently, safely and in accordance with public health directives. I agree that strict adherence and compliance with the Guidelines, and providing truthful and complete information about the status of my health and recent travel (if requested) is critical, including to protect and safeguard the health of others participating in or attending the Events. I agree that I will be responsible to make myself familiar with the Guidelines in effect at the time of the Events, and I agree that I will abide by and comply with those Guidelines, and any other policies that are communicated to me by ROS, and provide complete, truthful and accurate information in response to any inquiries, including inquiries about the status of my health and recent travel (if requested.)

Waiver and Release of Claims. In consideration of acceptance of my request to participate in these Events, I hereby agree to defend, indemnify and hold harmless ROS, its officers, employees, agents, other participants, sponsors, and volunteers (collectively, "ROCHESTER ORATORIO SOCIETY, INC."), to the fullest extent permitted by law, for and from any injury, damage, harm or loss incurred or suffered by me and any member of my household arising out of, resulting from or caused by, directly or indirectly, the attendance or participation in these Events by me, and I expressly agree for myself not to assert any and all claims, whether arising in contract, tort or otherwise, against ROS, relating to any such injury, damage, harm or loss, whether or not caused by the action, inaction, failure to act, fault, negligence, or conduct of ROS or otherwise except and only to the extent that such liability is the direct result of the gross negligence or willful misconduct of ROS. I understand that this waiver is intended to be construed and applied to the fullest extent permitted by law, and expressly applies to exposure to the COVID-19 virus and other communicable diseases.

<u>Recording of Events</u>. I understand that these Events will be filmed and/or recorded for further use by ROS, including to promote its programs and services ("advertisements"), and I consent to the use of my photograph, image, voice and likeness in advertisements, and in other uses by ROS, in any and all media, throughout the universe, in perpetuity, without remuneration.

<u>Legally Enforceable Document</u>. I recognize that this Agreement, including the waiver and release provisions, is intended to be an enforceable legal document and that I have carefully read and fully understand the provisions of this Agreement and having had a sufficient opportunity to consider its terms and have chosen to voluntarily enter into this Agreement by proceeding with registration for and participation in and attendance at these Events. All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the laws of the State of New York.
